The truth is, Planned Parenthood exists to perform abortions. They don't care about women's health.



Part I: The History of Planned Parenthood



Margaret Sanger is Born¹

Sanger was one of 11 children born into an impoverished family in New York.²

Margaret Sanger's Mother Dies from Tuberculosis³

While the doctors attributed her death to tuberculosis, Margaret believed her mother's early death was because she was weak from bearing so many children. This contributed to Sanger's belief that women should limit—or be limited—in the number of children they have.⁴

1914 Margaret Sanger Begins Publicly Advocating for Birth Control⁵

Sanger founded a pro-contraception publication. Because it violated the Comstock Act, Sanger faced possible jail time. She fled to England until the charges were dropped.⁶

1916 Sanger Opens the First Birth Control Clinic in the United States⁷

This clinic was in Brooklyn's Brownsville neighborhood. Sanger was arrested and spent 30 days in jail. She appealed the conviction, which was not overturned. However, the judge did make an exception to the law. This allowed doctors to prescribe contraception for medical reasons. This decision opened the door for the future legalization of birth control.⁸

1917 Margaret Sanger Begins Publishing The Birth Control Review⁹

This famous journal would run until 1940 and would be a haven for racists, eugenicists, and even Nazi writers.¹⁰

1921 Sanger Founds the American Birth Control League¹¹

The Birth Control Review frequently highlighted the League's mission. ¹² One advertisement read: "The American Birth Control League.

Its Aim: To promote eugenic birth selection throughout the United States so that there may be more well-born and fewer ill-born children — a stronger, healthier, and more intelligent race."¹³

1930 The American Birth Control League Founds the Harlem Clinic¹⁴

The Harlem Clinic was established in the poor African American neighborhood of Harlem, New York.

1939 The American Birth Control League Founds the Negro Project¹⁵

This project expanded on the work of the Harlem Clinic by providing contraception to African Americans in the South.¹⁶

Commenting on the project, Sanger wrote "We don't want word to go out that we want to exterminate the negro population."¹⁷ To avoid suspicions, the clinic paid individuals in positions of social power to speak about the benefits of birth control and family planning.¹⁸

1942 The Name "Planned Parenthood Federation of America" is Adopted¹⁹

The Board of Directors voted to change the American Birth Control League's name to the Planned Parenthood Federation of America.²⁰ Business continued as usual.

1948 International Committee on Planned Parenthood is Formed²¹

Sanger was an advisor on the project that formed the international arm of Planned Parenthood. The name was later changed to the International Planned Parenthood Federation.²²

Sanger Retires as President of the International Planned Parenthood Federation.²³

1966 Margaret Sanger Dies²⁴

Sanger died of congestive heart failure at the age of 86.25

Part II: What Does Planned Parenthood Actually Do? (Busting Common Myths)

Following Margaret Sanger's lead, Planned Parenthood's main goal is to perform abortions and promote contraception. Some affiliates now offer dangerous "gender-affirming" hormone "therapy" too.²⁶ Planned Parenthood also goes into schools and promotes its own brand of sex education.²⁷

Both contraception and sex-ed inevitably contribute to Planned Parenthood's profit from abortions.

Contraception leads women to engage in promiscuous sex, believing they cannot get pregnant. Then they discover that contraception is much less reliable than its promoters implied. Increased promiscuity and contraceptive failure lead to increases in unintended pregnancies. These women often kill their children through abortion.

Planned Parenthood's sex-ed programs encourage schoolchildren to act promiscuously and use birth control. This contributes to abortions, in the long run.

Planned Parenthood does offer other services including HIV testing; pregnancy testing; miscarriage care; and STD testing, treatment, and vaccines.²⁸ However, these services can also be found at 14,000 other federally qualified health service center sites in the United States.²⁹



ABORTIONS ARE ONLY 3% OF PLANNED PARENTHOOD'S SERVICES

In their 2022 report, Planned Parenthood states that abortions are 4% of their services.³⁰ Even they admit that the 3% claim isn't accurate anymore.

However, their calculation of percentages is confusing. Planned Parenthood counts each service as a unique interaction, even if one person received multiple services in a single visit.³¹

Example: a woman goes in for a pregnancy test and says that she's worried that her boyfriend is cheating on her. This woman receives an exam, STD testing, a pregnancy test, some type of prescription for STDs, and abortion counseling. Planned Parenthood would count all five as individual services, even though they were for one person.

When Planned Parenthood divides the number of abortions by the count of individual services, abortions are about 4%. However, dividing the number of abortions by the number of patients, we see that 17.6% of patients received abortions in 2022. When we narrow it down to just pregnant patients, the number who received abortions approaches 100%.³²


97.9% of pregnant women seeking "service" at Planned Parenthood get abortions.³³

PLANNED PARENTHOOD OFFERS PRENATAL CARE

Based on Planned Parenthood's own 2022 report, 97.9% of their pregnancy services are abortions.³⁴ Only 0.5% of pregnant women get adoption referrals and 1.6% get prenatal care of any kind.³⁵

One Planned Parenthood clinic webpage says, "If you choose to continue a pregnancy, we will provide you with a list of resources to help you obtain prenatal care." Many don't include prenatal care in their list of services. Their websites usually do not offer resources for it either. ³⁷

There are a few Planned Parenthoods that offer some prenatal care, but do not mention the nature of these services.³⁸ A few others specify that they offer early prenatal visits only.³⁹




PLANNED PARENTHOOD OFFERS ULTRASOUNDS

Technically, Planned Parenthood does provide ultrasounds. But they only use these ultrasounds to determine if the baby's gestational age is within the legal range for an abortion, or to guide them as they perform abortions.⁴⁰

In 2017, Live Action released a video showing that undercover callers had phoned 68 Planned Parenthood clinics across the US asking whether they performed sonograms. Sixty-five of them either didn't offer ultrasounds at all or only did them as part of the abortion process. Only three said they could do one to check the health of the baby.⁴¹

That same year, Sue Thayer, a former Planned Parenthood manager, spoke with Lila Rose of Live Action about the use of ultrasounds. She stated that they were only used for abortions. Moreover, clinic workers would purposely turn the monitor around so the mom could not see her baby.⁴²

PLANNED PARENTHOOD PROVIDES MAMMOGRAMS

Planned Parenthood's 2022 report lists "Cancer screenings and prevention" as 5% of their services. The breakdown includes things like breast care, pap smears, and HPV vaccinations. It does not list mammograms. ("Breast care" refers to the same kind of breast exam that a woman can do on her own at home).

Some Planned Parenthood facilities have allowed a mobile unit to park outside and offer free mammograms to their clients.⁴⁶ A few affiliates have a healthcare fund to help needy patients obtain services they cannot afford.⁴⁷

However, Planned Parenthood itself does not provide mammograms at its facilities.

Part III: Planned Parenthood's Illegal Activity

Planned Parenthood Covers Up Sexual Abuse⁴⁸

Abusers often use abortion to cover up sex trafficking crimes. If groups like Planned Parenthood have reason to suspect sexual abuse, they are required to report it.⁴⁹

However, Planned Parenthood fails to do so. This is not a mistake but a deliberate behavior that employees engage in and are trained in.⁵⁰

Studies have found that Planned Parenthood is the most visited clinic by trafficking victims. Survivors say it tends to be popular, despite being more expensive, because no one asks questions.⁵¹

Based on their recorded behavior, Planned Parenthood seems to have a "don't ask, don't tell" policy.⁵² Live Action's undercover investigations show that employees do not ask about the circumstances of the abortions they give to minors. They even go out of their way to avoid hearing details that would require them to make reports.⁵³

If Planned Parenthood has been informed of abuse, employees often ignore it. In one instance of child rape, employees faked records to avoid the "hassle" of reporting the abuse of a child.⁵⁴ Employees also ignored a girl who said she was being forced into having sex.⁵⁵

This behavior has even been caught on video. In an investigation of a Planned Parenthood in Indiana, girls posed as 13-year-old children seeking abortions. Planned Parenthood avoided reporting abuse and actively covered it up. ⁵⁶

Planned Parenthood Trains Sex Traffickers

In investigations at seven different facilities, Planned Parenthood staff helped men posing as sex traffickers by counseling them on how to get their victims tested, how to get abortions, and how to avoid getting caught.⁵⁷

They also coached sex traffickers on how to secure secret abortions and how to make their situations "look as legit as possible." They coached them on who they can talk to at the clinic, where they can take the girls for off-the-books abortions, how they should bring others to speak for the minors, and more.⁵⁸

They even instructed them to ensure that the children stick to "waist and up" or be "the extra bit of action walking by" if they need to have sex to make money while they recover from abortions.⁵⁹

Planned Parenthood Sells Body Parts from Aborted Babies

In 2015, the Center for Medical Progress released the first of several videos that showed Planned Parenthood employees discussing the sale of portions of aborted babies to labs.⁶⁰

In 2020, they released a video featuring a Planned Parenthood official's sworn deposition testimony describing "infants born alive and either harvested for organs or left to die inside abortion clinics."



The video footage speaks for itself. Dr. Mary Gatter talks about the best way to crush a baby to ensure that the organs that would be for sale would remain whole.⁶²

In another video series, a former StemExpress employee, Holly O'Donnell, discusses how her company would partner with Planned Parenthoods in California to obtain babies' body parts. At one point, O'Donnell discusses a baby whose heart was still beating following an abortion. O'Donnell says her supervisor, "gave me the scissors and told me that I had to cut down the middle of the face."

Part IV: Planned Parenthood's Racist Policies

Planned Parenthood's History of Racism

Sanger herself said, "We need not more of the fit, but fewer of the unfit...The propagation of the degenerate, the imbecile, the feeble-minded, should be prevented." 64

The weak-minded, the mentally defective, and those affected by poverty⁶⁵ served solely as a scapegoat since many African American communities suffered from unemployment, poverty, and crime.

Commenting on the Negro Project, Sanger wrote, "We don't want word to go out that we want to exterminate the negro population." While the meaning of this letter has been debated, Sanger's other writings, letters, speeches, and the voices she supported in her magazine, Birth Control Review, make clear her desire to control and limit the growth of the African American population.⁶⁷

Even employees of Planned Parenthood admit that the organization was, "Founded by a racist, white woman." 68

High Abortion Rates Among Minorities

This racism continues to this day. Abortion numbers among black and other minority communities are high, in comparison to the average population.

In 2018, more black babies were aborted in Manhattan than were born alive.⁶⁹ In the U.S. in 2014, the black abortion rate was 2.7 times that of the white population.⁷⁰

Black Dignity makes this bold statement:

"Since 1973, <u>abortion has reduced the black population by</u> <u>over 25 percent.</u> Twice as many African Americans have died from abortion than have died from AIDS, accidents, violent crimes, cancer, and heart disease combined."

Planned Parenthood Locations Target Minority Communities

While Planned Parenthood is not the only cause of the high abortion rate among minority communities, their policies specifically target these groups.

One of Live Action's undercover investigations revealed that Planned Parenthood was willing to accept money from a donor who wanted her money to only go to killing black children.⁷²

The organization Life Issues Institute analyzed Census Bureau data from 2010. They found that out of all Planned Parenthood's surgical abortion facilities, 79% are found near black or Hispanic neighborhoods. Moreover, 45% are within walking distance of both African American AND Hispanic communities.⁷³



They also researched the areas around Planned Parenthood's abortion mega-centers. They discovered that 22 out of 25 of these mega-centers target minority populations.⁷⁴

Planned Parenthood Focuses on Black and Hispanic Women

Planned Parenthood's own 2020-2021 Annual Report contains a section describing their newest Be Seen campaign. They describe the campaign as "A brand mission campaign that creates an opportunity to talk about Planned Parenthood's values with a priority audience: 18- to 29-year-olds in Black and Latinx communities."

For an organization steeped in racist and eugenic practices, calling black and Hispanic women of child-bearing age a "priority audience" is particularly sickening.

Part V: International Planned Parenthood's Reproductive Colonialism

History of International Planned Parenthood Federation (IPPF)

The International Committee on Planned Parenthood (ICCP) was founded in 1948. Originally, the ICCP was made up of four countries: the United States, Great Britain, the Netherlands, and Sweden. ⁷⁶

On Nov 29, 1952, the ICCP changed its name to the International Planned Parenthood Federation (IPPF), during the Third International Conference on Planned Parenthood. This conference took place in Bombay, India.

At this conference, IPPF expanded to include five more countries: West Germany, India, Hong Kong, Singapore, and Japan. 77

Margaret Sanger was the first president of the International Planned Parenthood Federation.⁷⁸ Today, IPPF operates in over 145 countries.⁷⁹

What does IPPF do?

Since its beginning, International Planned Parenthood has favored eugenics and population control.

One of IPPF's earliest constitutions states its goals. The constitution reads: "In the belief that a favourable balance between the populations and natural resources of the world is an indispensable condition of lasting world peace...International Planned Parenthood Federation sets the following aims...To stimulate appropriate scientific research in the following subjects: the biological, demographic, social, economic, and eugenic implications of human fertility and its control." 80

IPPF partners with local affiliates, providing them with funding and support. IPPF affiliates promote contraception, abortion, and pro-LGBTQ ideologies.

IPPF's Early Work

A report from 1967 describes IPPF's work in 50 countries. Often, they would work with the country's governments to promote contraception. These are some examples:

PAKISTAN In 1965, the Pakistani government wanted to reduce their own country's birth rate by 20% over 5 years. To advance the government's program, IPPF trained doctors, ran clinics, and donated mobile clinics to reach rural areas. IPPF's report reads, "The Association's main function within the Government's plan, is to carry out research, education, and publicity." Planned Parenthood also held meetings and offered home counseling. IPPF reports the success of the government's program: "By early 1967 there had been 252,355 IUD insertions and 5,400 vasectomies." Total 1966 grant amount: \$26,235.82

BARBADOS In 1966, Planned Parenthood focused on education and motivation. Their goal for 1968 and 69 was to reach, "60,000 women of childbearing age." Total 1966 grant amount: \$12,600.84


MEXICO From Dec 1966-April 1967, IPPF's brand-new affiliate in Mexico handed out contraceptives to 1,884 women and gave "advice" to 4,484. They also trained 81 doctors, social workers, and nurses and visited another 4,000 women. IPPF gave lectures on family planning to over 100 organizations. Total 1966 grant amount: \$90,000.86

KOREA Working with the government, IPPF ran an education and publicity campaign. They used radio, newspapers, and magazines to reach women. They also had a newsletter circulation of 20,000 families. IPPF trained 392 "family planning" workers, 885 doctors, and 539 midwives. Between IPPF's campaign and the government's family planning program, 400,000 women received IUDs in 1966 and 20,000 men got vasectomies.⁸⁷ Total 1966 grant amount: \$62,050.⁸⁸

IPPF and the Kissinger Report

During the 70s, IPPF's mission was incorporated into the Kissinger Report.

In 1974, the National Security Council finalized the National Security Study Memorandum 200, commonly referred to as NSSM-200, or the Kissinger Report. This document outlined a plan to control the global population, particularly in developing countries.⁸⁹



The Kissinger Report was a classified document of the United States government, which was declassified in 1990. It's basically a geopolitical strategy to harness the natural resources of the world for use by the US.⁹⁰

The U.S. government wanted to ensure political dominance in the international sphere. In order to limit the political power of less-developed countries, the U.S. government decided to reduce and control their populations.⁹¹ The Kissinger Report suggests contraception and abortion as means of population control, and it outlines specific countries to target:

"There are 13 countries where we currently judge the problem and risks to be the most serious. They are: Bangladesh, India, Pakistan, Indonesia, Philippines, Thailand, Egypt, Turkey, Ethiopia, Nigeria, Brazil, Mexico, and Colombia." ⁹²

Some short term "solutions" to reduce population are mentioned in the Kissinger Report. These include oral contraceptives, intra-uterine devices, sterilization, injectable contraceptives, and ovulation prediction methods. Section IV of the report discusses how to implement these methods and how much it would cost per year.

NSSM-200 also states, "**No country has reduced its population growth with-out resorting to abortion.**" In order to limit fertility, abortion would need to be incorporated into the laws and cultures of targeted nations.

Of course, if the government were to explicitly control the global population, this would result in a major scandal. So, the Kissinger Report passes off dirty work to non-profits such as IPPF. These non-profits would then operate through government funding.⁹⁴

IPPF is explicitly mentioned in NSSM-200 as a non-governmental leader in population control. This is not surprising, as USAID and the IPPF have a long history of partnership, going back to 1970.⁹⁵

It's important to note that the Kissinger Report continues to represent official United States policy on population control.⁹⁶

IPPF Today


Today, IPPF continues to implement the goals and strategies laid out in the Kissinger Report.

The goal of the IPPF is to make abortion legal and widely available, even in cultures that reject abortion. Part of their stated mission is to "enter into a dialogue with

political, religious, and cultural opinion leaders to liberalize their attitudes towards safe abortion." This goal is realized in developing nations.

A glance at IPPF's spending clearly shows the countries they target.

International Planned Parenthood's annual budget is more than \$125 million.⁹⁸ In 2022, the affiliates in these countries received the highest grants from Planned Parenthood:



Note that Pakistan, Ethiopia, Indonesia, India, and Nigeria are all countries specifically mentioned in the Kissinger Report.

Financial statements from 2018-2022 show the correlation between the Kissinger Report and IPPF's budget more clearly. During that time, Bangladesh, Colombia, Indonesia, and the Philippines also received one of IPPF's top-10 grants at least once. India, Pakistan, Ethiopia, and Nigeria received top grants for all five years. ⁹⁹ This means that eight of the thirteen countries mentioned in the Kissinger Report are still targeted nearly fifty years later!

IPPF's 2022 Annual Performance Report gives a few examples of their current agenda:

SUDAN IPPF lobbied for misoprostol (the second drug of the chemical abortion cocktail) to be labeled as a "National Essential Medicine" in Sudan.¹⁰⁰ Planned Parenthood's website describes how women can have an abortion using only misoprostol.¹⁰¹ IPPF also lobbied for Sudanese nurses and midwives to legally provide contraceptive implants.¹⁰²

COLOMBIA IPPF praised Colombia (notably, one of the key 13 countries the Kissinger Report identified) for decriminalizing abortion. Abortion was previously outlawed in Colombia, but the IPPF took part in political activism to make abortion legal. ¹⁰³

SUB-SAHARA IPPF sponsored a campaign (entitled "Treasure Your Pleasure") encouraging young people to engage in various sexual activities including LGBTQ relationships. The report states, "Treasure Your Pleasure reached young people across the continent with fun, educational messaging on Facebook, Instagram, TikTok, Twitter and YouTube...the inclusive campaign embraced all types of pleasure for all people, regardless of their sexual orientation, gender expression or identity."¹⁰⁴

CONTRACEPTION IPPF gave over 80 million women contraception or contraceptive counseling in 2022.¹⁰⁵

ABORTION IPPF performed approximately 5 million abortions (or offere-pro-abortion "services") in 2022. 106

COMPREHENSIVE SEX-ED In 2022, IPPF taught 35 million school-children about contraception, abortion, and casual sex through online and in-person programs.¹⁰⁷

India — How IPPF has been controlling the population over the years

India was one of IPPF's original 8 affiliates. It's also one of the countries mentioned in the Kissinger Report.

1949: Family Planning Association of India is formed

1952: FPAI joins International Planned Parenthood at the Bombay Conference.

1961: India's total fertility rate is approximately 6 children per woman. ¹⁰⁸

1962: IPPF's newsletter discusses the push to sterilize Indian couples. Before getting sterilized, Indian couples must be told that it's a reversible procedure. However, IPPF admits that this isn't always true. Their newsletter also states, "Small monetary inducements are offered to poor persons of either sex willing to undergo sterilization." 109

1966: \$73,411 is spent in India (2023 equivalent: \$697,379). IPPF's yearly report states, "The over-all target is 20 IUD insertions per 1,000 in urban areas and 10 per 1,000 in the countryside. The vasectomy aim is 2-5 per 1,000. Over a year this would mean 6 million IUD insertions and 1 – 23 million vasectomies."

1970s: Planned Parenthood in India "Initiated comprehensive sexual education for youth."¹¹¹

1974: Kissinger Report names India as one of 13 specific countries to target population/fertility control.

Late 1970s: Indian men and women urged to get sterilized. Dramatic increase from previous years. 112

2015: Indian family size is drastically reduced. It's rare to see couples with more than 2 kids.¹¹³ Family Planning Association of India also receives IPPF's top grant for the year: \$3,668,737.¹¹⁴

2017: Years of IPPF's influence takes its toll. Indian total fertility rate is reduced to 2.2 per woman.¹¹⁵

2020-22: Family Planning Association of India continues to receive one of IPPF's top-10 grants each year. 116


Part VI: Planned Parenthood: The Numbers

Part VII: Defunding Planned Parenthood

What Does Defunding Planned Parenthood Mean?

This is a general term for taking tax funding away from the organization. This money would instead be spent on other women's healthcare groups.

According to Planned Parenthood's 2021-2022 Annual Report, 36% is private donations, 35% of their funding is government money, 19% is health services revenue, and 10% is from other sources.¹³⁵

By law, taxpayer money cannot fund abortions, but money is fungible. When an organization has a large amount of money, it can shift funds around to fund whatever it wants.

If Planned Parenthood were defunded, they would lose 35% of their income. In 2022, this amounted to \$670.4 million. ¹³⁶ Losing millions of dollars would drastically reduce Planned Parenthood's ability to provide abortions, even though this money technically cannot be used for abortions right now.

7 REASONS PLANNED PARENTHOOD SHOULD BE DEFUNDED

- Planned Parenthood focuses on political and administrative spending over healthcare. With more funding, they spend their own money building up structure and lobbying power.¹³⁷
- They don't use their money well. In 2017, there were records of over 50 publicly known audits of Planned Parenthood's financial data. Most of these audits uncovered overbilling, waste, abuse, and fraud.¹³⁸
- Planned Parenthood illegally bills abortions to Medicaid. Several audits detail unbundling schemes to use taxpayer money to fund parts of abortions. These involved charging abortion-related services to the government, such as the drugs used and counseling visits, but not the abortion itself. In some cases, it appears that the state was directly billed for abortions.
- Public funding of abortions does not help women's health, it endangers their lives. Research has shown that cutting public funding for abortions decreases both the number and proportion of hospitalizations.¹⁴²
- Planned Parenthood's other services, such as handing out contraceptives, do not reduce abortions. 143 94.5% of women seeking abortions were either on contraception or had no difficulty accessing contraception, when they became pregnant. 144
- As shown in Part III of this book, Planned Parenthood has been caught covering up sexual abuse and ignoring victims' stories.
- Planned Parenthood's health services are provided by others. Planned Parenthood does provide services like STD testing. But there are more than 14,000 other low-cost health clinics that will provide care no matter the financial status of the patient.¹⁴⁵

The above study from the Guttmacher Institute shows that 54% of women obtaining abortions were using contraceptives during the month they became pregnant. Of the other 46%, only 12% reported issues getting contraception for any reason. That means that only 5.5% of women who got abortions had trouble getting birth control. So, 94.5% of these women either were on birth control or had access to birth control.
